Mission Statement: Healthcare built on the fundaments of patient safety, equality, universal access and healthcare of high quality. To achieve this, the nursing profession must attain substantial influence in the EU legislative and regulatory processes.

Objectives: To ensure that nursing policies on equal access to high-quality healthcare services for the benefit of the health of the citizens in the European Union and in the wider Europe are transformed into beneficial EU legislation, recommendations or guidelines.

- (4) Nursing Research.

Goals:

- (1) Quality & Safety
 - EFN members' actions in Quality and Safety are brought into the political arena.

 - EFN members' actions in eHealth are brought into the political arena.
- (4) Nursing Research
 - EFN Position advocated towards EU Institutions and Stakeholders

Measurement:

- (1) Quality and Safety
 - EFN members' good practice examples on Quality and Safety are shared throughout the EU.
- (2) Cross Border Health Directive
 - DG Sanco legislative proposal and recommendations reflect EFN position on Health Services;
 - EFN amendments are taken into account in the European Parliament.

 - EFN members' good practice examples on eHealth are shared throughout the EU.
- (4) Nursing Research
 - Creation of the European Florence Nightingale Nursing Research Network (EFN-NRN)

- (3) Nursing Research
 - Constitution & first operational settings in 2011

Tactics:

 - EFN providing input to Joint Action.
- (2) Cross Border Health Directive
 - EFN lobby in European Parliament in relevant committees and 2nd reading in the European Parliament;
 - EFN to lobby EU Presidencies on political debate on Commission legislative proposal;
 - Alliance Building EPSU-HOSPEEM
- (3) E-Health EFN members' best practices are basis for Policy Document.
 - EFN member of the E-Health Stakeholder Group
 - EFN providing input to Joint Action.
- (4) Nursing Research.
 - EFN members leading on the development of the EFN-NRN.

Actions:

 - EFN amendments to the legislative proposal based on EFN Position;
 - EFN advocating for Policy synergies between EC, WHO RC and Council of Europe.

 - EFN members of national platform e-Health.
- (4) Nursing Research
 - Develop the EFN-NRN Constitution & operational settings

Outcome:

 - EU legislative outcomes in line with EFN policy;

 - EFN members experience in e-health is shared at European level;
 - Nurses using E-health technology to increase quality and safety.
