EFN MEMBERS APPLICATION TO ORGANISE A GENERAL ASSEMBLY

In line with most Pan European Organisations operating in Brussels, EFN has no particular selection criteria for an EFN member willing to host an EFN General Assembly in his/her country. All the members can ask to organise it. The only condition is that one General Assembly has to be in Brussels (April) and the other one can be abroad (October) – so, only one EFN General Assembly can be organised outside Brussels, hosted by an EFN member.

Procedure to be followed by the EFN Members:

- Inform the EFN Secretary General, at any time, that you want to organise an EFN General Assembly (GA) in your country
- Make it clear when you would like to host the GA and check if that year is not taken already!
- The decision on the dates is on first come first served basis - preferably ask well in advance (2 years at least).
 - If nobody else requested to organise a GA on the date you want, then you are put in the list as hosting the GA for that date.
 - But, if there are more candidates for that specific year/date, then it is up to the EFN members applying to host to talk to each other and decide which NNA organises the GA and when
 - A preference can be given to the EFN Member holding the same period requested the EU Presidency (see list below of upcoming EU Presidencies).
- For now, the next GAs are already fixed as follow:
 - ✓ Brussels, April 2019
 - ✓ Greece, October 2019
 - ✓ Brussels, April 2020
 - ✓ Estonia, October 2020
 - ✓ Brussels, April 2021
 - ✓ Croatia, October 2021
 - ✓ Brussels, April 2022
 - ✓ Czech Republic, October 2022 (*Requested - Having the EU Presidency*)
